






Installation Tips

Before you begin installing this assembly, read all instructions thoroughly.

This Lock Box is designed to be used on the model vehicles described above. Use of this Lock Box in any other vehicles or failure to install this Lock Box properly may result in an improperly mounted seat and could result in unexpected movement of the seat and loss of control of the vehicle, thereby placing the occupants of the vehicle and others in a potentially dangerous situation.

WARNING Ensure this Lock Box is securely shut and locked before operating the vehicle. Failure to do so could result in the drawer opening creating a potentially hazardous driving situation.

WEAR SEAT BELTS AT ALL TIMES



Under Seat Lock Box Installation Instructions

Parts List Key, Qty - 2 Lock Box, Qty - 1 Foot, Part Number 476.15, Qty - 1 Security Cable, Part Number 476.16, Qty - 1 M4 Phillips Head Screw, Part Number 476.16, Qty - 4


Permanent Installation – Install Foot

To permanently install the Lock Box under the front seat, use the M4 Phillips Head Screws to mount the foot to the bottom of the box.




2 Remove Front Seat Mount Bolts

Slide the driver's side seat back to access the front seat bracket bolts. Use a 13 mm socket to remove the bolts. Set them aside to be reused later.




3 Loosen Rear Seat Mount Bolts

Use a #50 Torx and a universal joint to loosen the rear seat mount bolts. Do not remove them.




4 Slide Lock Box Under Seat

Tip the seat back and slide the Lock Box under the seat with the tabs under the brackets. Align the mounting holes with the holes in the seat brackets. Make sure the foot is not on top of any wires.



5 Reinstall Seat Bracket Bolts

Reinstall the bolts removed in Step 3 to secure the Lock Box to the seat mounting brackets. Loosely tighten the rear seat mount bolts. Slide the seat back and forth to make sure it operates easily. Tighten all bolts securely.


Under Seat Lock Box Installation Instructions



Universal Installation – Secure Cable

For a quick installation, wrap the looped end of the cable around a secure object. Thread the lock end of the cable through the loop. Insert the lock into the slot on the Lock Box. Turn and remove the key.

Secure the box in a location where it will not interfere with vehicle operation.
